- b) Porta-Potty: We have notified the vendor that we are discontinuing our service.
- c) Restrooms: City restrooms are open for the season but are currently having some sort of backup problem. It is being resolved by the city.
- d) Wiring: Still need to run connection to our container. Attempts thus far have not been successful due to the electrician's availability. Next target date is 4/11.
- e) T-shirts: We have youth t-shirts in stock for sale at the club run days. Several colors are available. Cost will be \$7.50 each.

III. New Business

- a) Run Day: Next run day is 4/18. Workers needed. Track cleanup needed.
- b) New Track: layout of the new trackage for the passenger siding has started. Will need heavy equipment to push dirt around as the next step.
- c) Fencing: the fencing contractor has been contacted to put in a personnel gate near the restrooms. This will become our run day entry point. Hope to have it done before run day on the 18th.
- d) Roster: The secretary will publish the 2015 roster within the next wek or so.
- e) Antique Tractors: Discussions are in the works to possibly invite a local antique tractor / stationary emgines club to one of our run days. Maybe in October or November. More discussion to follow.
- f) Newsletter/Mailing: Robby Mossman has volunteered to organize and distribute an email-based newsletter. A link will be added to the website to allow people to sign-up for the mailing.
