### **IV.** Old Business

- 1. Club Steamer failed boiler inspection do to leaking throttle. Bob Cummings has taken the steamer home and is planning on installing a smoke box throttle.
- 2. Run day photo opportunity. If we have manpower available we should have someone stationed with our photo op locomotive during run days. For the next run day we may not have a display locomotive.
- 3. Several people were asked about purchasing an additional club member container but no commitment yet.
- 4. Reiterated that children riding alone must be able to keep their feet flat on the floorboards and that the station master has the authority to require children to be accompanied by parents.
- 5. As mentioned earlier we had our annual boiler inspection on 9/22. Everyone passed except club steamer. We have requested an additional inspection on either 10/19 or 10/20 for David Nicol who was unable to attend the 9/22 inspection. Anyone else who needs to have an inspection will be invited to attend.

- 6. Bill Leahy stated that he is reviewing the by-laws and expects to make recommendations this year.
- 7. We received \$1,200 from the movie company and a truck full of buildings was delivered.
- 8. Scott Moore is continuing work on the small electric switcher.
- 9. A bracket has been installed to accommodate 4 horns under the hood of the club diesel. One horn has been installed temporarily (for safety) but the complete installation will be done after the next run day.

## V. New Business

- 1. Ethel Nicol brought up the problem with people standing in line in the sun on hot run days. We discussed various alternatives: 10x20 pop ups, a shade screen or a wooden structure like a classic train station. We said we would discuss this in the future.
- 2. We are planning on sealing the buildings this week on site. Emails will be sent to membership with details.
- 3. Scott is also recommending rewiring the club diesel to add some fusing to protect the electrical system. Again this would be after the next run day.
- 4. Planning a work day 10/20 to finish West Loop Doubling
- 5. Some site prep for new bridge concrete forms was accomplished.
- 6. A large tree limb fell and was leaning against a tree next to the track leading down to the Nicol bridge. It was thrown over the cliff.
