- c) Boy Scouts- Norm talked with Walt, who is the superintendent with the NRMA about doing a merit badge program at NGLS. Further discussions will be needed.
- d) Grade Crossing- Project is pending weather and labor but everything is ready. The plan is to try and do the project during the week in order to save money on concrete costs. Discussed need for about 7 days for concrete to set with an estimated cost of about \$400
- e) Training and Certification- Discussion was had around training and certification to use the club steam engine and club diesel.
- f) Construction Plans- Discussion around track construction plans where had which included grade crossing, sidings, loop, bridge, along with track repair needs to close gaps and check gauge. Estimated costs for ballast supplies between \$600-\$700.
- g) New building workshop
- h) Robby Mossman- Grants request with J.B. Hunt is still pending and no updates available at this time.
- Boiler Inspections and regulation changes. Rob Hoppe is still waiting to schedule his state representative to come to the site to explain what we are looking to do legislatively. It was suggested that we include the 2 Reps for the Horse Park. A position paper is still needed before reps are invited. A need to provide a distinction between commercial and hobby boilers is one of the focuses of the change request.
