- 1. Bill reviewed the minutes from the last meeting. The minutes where accepted
- 2. Joe provided an update on the riding car project. He mentioned that he is taking measurements and putting the plans together and looking for volunteers to build the frames. Dave Levy mentioned that he and Wayne Lass have looked at the trucks that are to be used and that they will need wheels and brakes.
